- If payment is overdue for more than one month, the account will be suspended until payment is collected. Overdue invoices will be charged 1 ½ % per month – 18% annum interest charge. If collection efforts are necessary, Applicant agrees to pay all costs of collection including, but not limited to, investigator fees, collection agency charges, mechanic’s liens filings, title report fees, collection costs, attorney’s fees and court costs incurred.
